Robert Welch

Mr. Welch is an experienced CEO, CFO, and senior executive who has enjoyed many successful entrepreneurial ventures in his career. Some of the highlights of Bob's 45-year career include:

- In 1979, Bob formed Zitel Corporation, backed by Silicon Valley investor Jack Melchor, a spin-out of a profitable memory system division of National Semiconductor where he had been a founding division GM for 4 years. In 1983, after achieving substantial profitable growth, Welch and his management team, at the behest of Intel CEO Silicon Valley legend Bob Noyce, acquired Intel's Memory System Division. On the strength of that acquisition, Bob took the company public with Kidder Peabody and Woodman, Kirkpatrick and Gilbreath a boutique west coast banking firm (IPO, ZITL: NASDAQ). In 1987 Welch retired as CEO yet remained actively engaged on Zitel's Board until 1999.
- In 1987, shortly after announcing his retirement, Bob was urged to form a management consulting company by one of his Zitel Board members, Bill Lonergan, representing an East Coast VC firm which was a Zitel investor. Bob formed Coast Ventures, LLC., with Oxford Partners, as his first client, helping manage their west coast investments in local bay area companies. Bob has continued his financial management consulting with startup and emerging companies as CEO of Coast Ventures, Inc., through 2020, positioning his clients internally and strategically for profitable growth and maximum ROI for their management teams and investors.
- In 1996, Bob co-founded Telegra Co., a network test system supplier, with two
 engineering co-founders. After two years of highly profitable growth, Bob and his
 team sold Telegra to Agilent Technologies Inc. (NYSE:A), formerly a \$200 million
 division of Hewlett Packard, headed by Bill Mortimer, Senior VP, in 1999 for a
 significant return on investment to the management team and Telegra investors.
- As one of the early investors and Board Members at Cleantech America, LLC, a utility-scale power company, in 2006, Bob served as CFO and financial advisor to CEO Bill Barnes. Cleantech was awarded the first Solar Power Purchase Agreement by PG&E resulting in the construction of the first 5-Megawatt solar power facility in CA connected to the electrical power grid. In August 2009, Bob helped manage the sale of the company to Meridian Energy, LTD, of New Zealand, who purchased Cleantech to establish a U.S. footprint.
- In late 2017 and early 2018, Bob served as a financial consultant, CFO, and Director of AMI, Inc. (now Au Terre, Inc.), where he structured and managed the conversion

of the company from an LLC into a full corporation. In addition, he created all the financial documents for the company, including a Private Placement Memorandum and related investment documents for the sale of equity to private investors.

In June 2018, Bob co-founded 1Point Merchant Solutions, Inc., a credit card processing company, with a dear friend, Wayne Keddy, a 40+ year veteran in that industry and former CEO of a successful credit card processing company that had been recently acquired. As CFO, Bob was responsible for all financial matters, including the management and the closing of a \$500,000 investment in early 2019 with a multi-branch community bank in Oregon which was one of 1Points customers, utilizing Convertible Promissory Notes with Warrants attached. Sadly, Keddy passed away suddenly, in November 2019, necessitating the winding down and closure of the business, which Bob managed to completion. Keddy's legacy lives on in the hearts and minds of his family and all who loved him.

Bob earned his BSEE degree in 1963 from West Virginia University. In 2005, he was honored with induction into WVU's "Lane Academy of Electrical Engineering" where he is recognized for his contributions to the industry and to the University.
